#### 16 Days of Action Again Violence

The annual campaign 16 Days of Action starts on 25 November 2019. This campaign raises awareness to end violence against women and girls around the world. Locally the Stirling Gender Based Violence Partnership is putting on a variety of events and activities but would also like to support communities to put on awareness raising events across Stirling during this time. Themes this year include coercive control and how the new Domestic Abuse legislation is working; Sexual Harassment; safe dating and how communities can recognise and challenge gender based violence.

Communities can participate in a variety of ways including holding exhibitions, film nights, talks, distributing publicity and awareness information or simply making people aware of the ways to recognise and challenge gender based violence. #### Connect people to nature through - #LetNatureSing campaign

Nature is in crisis and one of the biggest threats it faces is our disconnection from it.

RSPB Scotland recognise the need to connect people to nature, and on Thursday 17<sup>th</sup> October they will be staging their biggest event yet as part of our **#LetNatureSing** campaign – they will flood public spaces (think travel hubs, museums, office buildings, shopping centres, tourist attractions...) with the sweet sound of birdsong for one day only. That's where you come in...

#### What do they need from you?

• A commitment to play birdsong (they will provide the soundtrack) in your venue on 17<sup>th</sup> October for all your customers, commuters, tourists and visitors to enjoy. This can be for all or part of the day, even just an hour over lunchtime would make a huge impact.

A simple 'Yes, count us in!' is all we need just now.

#### Why get on board?

- With over half of all species in the UK in decline, our natural world is facing an immediate crisis and the environment is now cited among the top three pressing issues facing the nation.
- Let Nature Sing Day will not only give nature a voice in the urban spaces of our towns & cities, but draw collective attention to how everyone can all help in a small way to stop it's decline.
- The sound of birdsong reminds us all of our deep connection to and love for the natural world the Scottish people showed how much this meant to them when they bought our charity single of pure birdsong back in May, helping it reach #2 in the Scottish charts, and #18 UK wide.

#### What happens next?

In September I'll send you everything you need – a beautiful soundtrack of native birds singing and the images, logos, posters and even a handy 'Top 10 Ways to Help Nature' to help you support the event.

Let Nature Sing Day is set to be covered extensively across the media, and will have the full whack of RSPB Scotland social media, PR and marketing behind it both in the lead up and on the day so they are sure to make a big splash!

#### European funding for low carbon and active travel



European Union European Regional Development Fund

A third round for the European Regional Development Fund (ERDF) Low Carbon Travel and Transport Challenge Fund is now open and available for applications.

Public, community and third sector organisations can now apply for £13.25 million of available ERDF and Scottish Government support to help deliver innovative active travel and low carbon transport hubs, delivered through Energy Saving Trust. £8.4 million has been provided through ERDF and this investment will continue to help people and communities throughout Scotland to benefit from further sustainable and greener travel options and help further strengthen Scotland's contribution to global efforts to prevent damaging climate change.



While match funding is required, applications can cover 70% or 80% of the total project costs depending on location. Eligibility criteria have also been tailored to broaden the range of applicants and to encourage applications that will benefit rural communities.

The fund is now open with a deadline for applications of 25 October. In order to assist communities interested in applying for support, Energy Saving Trust is hosting a series of events to support organisations through the application process; webinars and surgeries that will take place throughout August and September.

#### The Good Exchange - How can I close my funding gap?

Some of the biggest challenges faced by charities and community groups today are how to find out which organisations are giving grants, donations and match funding to good causes like theirs and managing the multiple application processes. The Good Exchange's proactive matching technology offers the solution.



Any registered charity or other group (Applicant Organisation) that operates for public benefit in the UK can use **The Good Exchange** to apply for funding and fundraise for a recognised charitable purpose, attract donations and raise funds.

Through their personalised dashboard, Organisations can see exactly how many potential Funder matches have been identified, the number of funding shortlists on which their project has been placed, the number of funding offers that the project has received and the total amount of money raised and still to be raised to meet the project's target.

#### FREE Challenge Poverty Week media training

The Poverty Alliance is offering free training sessions on how to talk more effectively about poverty in the media and online.

The Joseph Rowntree Foundation and the Frameworks Institute <u>have carried out a lot of research</u> into what views people have about poverty, and what messages organisations can use to change them.

The Poverty Alliance wants to help its members and supporters start using these messages to **talk about poverty** in a helpful way, and they are offering free half-day training sessions on how to do this – with a focus on how to engage with your **local media**.

#### Managing Your Finances! for voluntary organisations & charities

The main aim of the training is to provide guidance around effective accounting records keeping for voluntary organisations, including charities. The objectives of the course are:

- To understand effective accounting record keeping for managing your organisations finances
- To understand and complete essential processes, including bank reconciliations
- To set up and operate our small accounts spreadsheet for voluntary organisations
- To provide practical free resources for future use by your organisation

Many small charities and voluntary organisations do not have the luxury of having a finance team in place. Most are reliant on committee members, volunteers and staff who have a variety of other duties, as well as managing the finances. It often feels a complex area to tackle and may not be top priority. However, there are some essential finance processes that can be put in place that can help. SVE provides training and practical resources that can assist small charities and voluntary organisations to ensure they practice good financial management.

#### What essential finance processes are needed?

The foundation of good financial management in small charities and voluntary organisations is to keep it simple. Basic accounting records are a must to keep track of funds. SVE's simple spreadsheet can be used to record income, expenditure, as well as unrestricted and restricted funds. The system also generates finance reports that can be used for committee meetings.

What is important however, is that these basic records are kept up to date and to have a good filing or referencing system so any document or information needed can be easily retrieved. In a small organisation, maintaining the books and records will often be the sole responsibility of one person but it is good practice for all committee members or trustees to understand and oversee the processes. It is therefore advisable for more than one person from an organisation to book on this training.

#### Free CPD Workshop on Impact Evaluation for Youth Work

As Scottish youth work faces an ongoing funding crunch, organisations are under increasing pressure to demonstrate results in ways that align with national government and education priorities. YouthLink Scotland is offering free open CPD sessions on evaluating the impact of youth work offerings, focused specifically on helping you demonstrate the contribution your work makes to achieving the goals of the Scottish Attainment Challenge.

These sessions will cover:

- Establishing clear outcomes of your work that fit with both local needs and national frameworks. •
- Finding the right indicators to measure how you are achieving those outcomes.
- Choosing data-gathering methods that work for your context and minimise additional burdens on youth • workers, young people, and your organisation's time.
- Formulating the right questions to ask to get the information you need.
- How to use the data you collect for a variety of purposes for example, funding applications, growing local • partnerships, and internal improvement efforts.

The majority of the sessions will be a collaborative workshop offering attendees the chance to walk away with a fully realised plan for documenting one or two specific impacts of your youth work offerings and ideas for effectively using the evidence you gather.

Because different perspectives are important in establishing what your most important outcomes are and what the constraints on measurement strategies might be, it is recommended that each organisation send two attendees to the workshop – one youth worker or volunteer and one member of the organisation's leadership team. A pre-activity for gathering useful input from young people who participate in your programmes will also be distributed 2-3 weeks in advance of the workshop.








#### Under Pressure Training

- Reflect on a range of youth work interventions and approaches that are helping to close the poverty related attainment gap.


