#### **Independent Care Review: Council statement**

Stirling Council acknowledges the publication of the Independent Care Review Scotland

Your Stirling: You Decide, Stirling's approach to participatory budgeting, is proceeding well. From the successful proposals, the Delivery groups for each proposal have worked with Council Officers to finalise completion or come up with final choices for communities where needed.

#### Consultations

#### Gender Recognition Reform (Scotland) Bill: A consultation

In a statement to the Scottish Parliament in June, the Cabinet Secretary for Social Security and Older People, announced that the Scottish Government would consult on a draft Bill to reform the process by which trans people gain legal recognition of their lived gender through a Gender Recognition Certificate – a right they have had for 15 years.

To comply with international human rights law, Scotland must have a system for obtaining legal gender recognition. The current system is viewed by many applicants, or would-be applicants, as demeaning, lengthy, and stressful.

This consultation seeks respondents' views on the provisions of the draft Gender Recognition Reform (Scotland) Bill which amends the way in which a trans person can obtain that Certificate (a "GRC"). The draft Bill does not make provision to change the rights and responsibilities arising as a result of gender recognition nor to change existing arrangements under the Equality Act 2010.

#### Scottish Schools (Parental Involvement) Act 2006 – Statutory Guidance

Parents know their children best and children do better when parents are involved and engaged with their learning.

In 2006 the Scottish Parliament passed the Scottish Schools (Parental Involvement) Act. This important law sets out how schools and councils must work to support parents to be involved in the life and work of schools and in their children's learning.

Over the past year, the Scottish Government has been working with a number of people to update, strengthen and make the guidance clearer. The Scottish Government is now asking for your views and feedback on a fresh guidance document.

#### **Henry Smith Charity: Improving Lives Grants**

Grants for small and medium sized organisations in the UK to support projects and the running costs of organisations.

The Improving Lives grant programme provides grants to charitable organisations that help people when other sources of support have failed, are inappropriate, or are simply not available.

The Henry Smith charity supports established organisations delivering services directly to beneficiaries. They are looking for services which can demonstrate a track record of success, and evidence the effectiveness of the work. This is the largest grants programme which the Henry Smith charity runs, through which the majority of its funds are

#### Launch of Child Poverty Fund

The Scottish Episcopal Church is launching a fund which will help to target child poverty in Scotland. Grants of up to £5,000 will be awarded for a pilot period of one year for congregational programmes specifically focussed on the alleviation of the effects of child poverty.

The initiative follows discussion on child poverty at General Synod 2018. The church recognises that child poverty is a wide-ranging and complex issue and encourages its congregations to work with other partners whether ecumenically, with other faiths or with secular groups/agencies.

#### **REACH Grants Programme**



The Reach programme is suitable for charities who can demonstrate

they address disadvantage or social exclusion. Organisations with an income less than £1 million per annum will be able to apply for grants of between £1,000 and £20,000 over one year to support vulnerable people.

The Programme opened on **Monday 10 February** and the first deadline is **Thursday 2 April 2020**. For more information click here.



#### **Baillie Gifford Awards**

Foundation Scotland would like to draw attention to three opportunities that are available from its Baillie Gifford awards programmes.



#### **Multi-year Grants**

This is an annual programme that offers grants of between £2,000 and £5,000 per year up to a maximum of three years. The fund can support 100% of the project

costs if the total cost does not exceed £15,000. The programme will accept applications that exceed £15,000 over three years, so long as the grant request is for at least ¼ of the total project costs. In these cases, the maximum project cost can be for no more than £60,000 over three years.

Priority will be given to projects that can demonstrate a fit with one of the following themes.

- Reducing isolation in Scotland's communities this includes all forms of isolation whether due to health, disability, rurality, or projects which aim to tackle barriers to inclusion. This list is not exhaustive.
- Supporting financial inclusion this can include food poverty-related projects and those that seek to maximise the income of families that may be struggling due to the impact of Universal Credit, disability, in work poverty and so on.
- Overcoming homelessness this includes any work to tackle homelessness in our communities.
- Improving employability and enterprise, particularly in young people

The deadline for applications is 4pm on Friday 10 April 2020.

#### **Baillie Gifford Community Awards**

This programme runs 4 times a year and offers grants of up to £2,000 (towards a maximum project cost of £8,000). Applicant organisations should have an annual income of less than £250,000. Priority goes to projects in the following areas: Children and families, Elderly, Education, Environment, Health, Physically disabled, Homelessness, Women and Grass Roots Sports.

The deadlines for this programme in 2020 are 2 March, 25 May, 24 August and 2 November.


